1. Meeting called to order at 7:02 pm
 - a. Roll call:

 - e. Motion by Uihlein support by Mullins to pay the bills of August 1, 2021 through August 31, 2021. The request was made to have a breakdown of credit card bills available for review in the future.

b. Christine Landis discussed the problems she is having with people locating her dance studio which is located off the Wood Street parking lot. Possible sign placement on the main streets, assistance with google maps were discussed.

c. Motion by Quintanilla support by Uihlein to table improvements to the DPW building until a contractor supplies a quote. All in favor. Motion passed.

d. Motion by Mullins, support by Uihlein to allow Kim and Laura Morehouse to combine to parcels at 506 and 510 East Main. All in favor. Motion passed.

6. Committee reports:

a. Personnel committee gave an update.

b. Quintanilla and Howlett will look into fencing along the west boundary of the Village property. Motion by Howlett support by Cattell to have this surveyed with a cost not to exceed \$3,000.
