Unfinished Business:

1. Discussion of Site Plan missing information Dogs Help, LLC

Motion to Accept proposed Site Plan Revision No. 4 on October 12, 2021, with the
following conditions:

- a. The Applicant will provide documentation acceptable to the Zoning
Administrator and the Planning Commission Chair reflecting the locations of
existing and proposed service facilities above and below ground, including
chemical and fuel storage tanks and containers, water supply facilities,
sanitary sewage disposal facilities, storm water facilities, and easements.
Within these documents, the Applicant will provide transformer pad location
and method of screening.
- b. The Applicant will provide interior description of the new building to justify
a minimum of 32 parking spaces between the old and new buildings. Also,
Applicant will revise the parking space calculation on the Cover Sheet.
- c. Applicant will remove "future" from paved parking spaces on the plans.

- d. Applicant securing a storm water easement from the Village.
- e. Applicant drafting and recording an access easement from Parcel 1 to Parcel 2 that
is approved by the Village of Stockbridge attorney.
- f. Applicant to provide the number of new employees by this issue.
- g. Applicant to remove 6 parking spaces from final plans that face Bird Drive or provide required landscaping.
