# RESOLUTION OF INTENT TO CREATE AND PROVIDE FOR THE OPERATION OF A DOWNTOWN DEVELOPMENT AUTHORITY

WHEREAS, the Village of Stockbridge has undergone stagnation in the property values of its central business district and in its economic growth,

WHEREAS, The Council for the Village of Stockbridge has determined that it is necessary for the best interest of the residents of the Village and the surrounding area to halt this stagnation, to increase property tax valuation to encourage new economic growth and development within the Village and to eliminate the causes of existing commercial property value stagnation,

IT IS THEREFORE RESOLVED, that the Council for the Village of Stockbridge hereby finds it necessary and declares its intent to create and provide for a Downtown Development Authority and designates a Downtown Development District pursuant to Act 197, P.A. 1975, as amended.

IT IS FURTHER RESOLVED, that the proposed boundaries of the Downtown Development District shall conform to the corporate boundaries of the Village of Stockbridge.

IT IS FURTHER RESOLVED, that a public hearing on the adoption of a proposed ordinance creating the Downtown Development Authority and providing for its operation be held on Monday, May 16, 1983, commencing at 7:30 o'clock in the evening at the High School Cafetorium, 416 North Clinton, Stockbridge, Michigan.

IT IS FURTHER RESOLVED, that the Village Clerk shall cause to be published a notice of the public hearing twice in a newspaper of general circulation in the Village of Stockbridge, not less than twenty (20) nor more than forty (40) days before May 16, 1983, and shall also mail a copy of the same to all property taxpayers of record in the proposed district, being the Village of Stockbridge, not less than twenty (20) days before May 16, 1983, and shall also cause to be posted in at least twenty (20) conspicuous and public places in the proposed Downtown District not less than twenty (20) days before May 16, 1983.

#### ORDINANCE NO. 1100

(Enacted <u>May 6, 1985</u>)

A ORDINANCE TO ESTABLISH A DOWNTOWN DEVELOPMENT AUTHORITY
PURSUANT TO ACT 197, PUBLIC ACTS OF MICHIGAN, 1975;
TO PROVIDE FOR THE ESTABLISHMENT OF A GOVERNING BOARD FOR
THE AUTHORITY; TO DEFINE THE BOUNDARIES OF THE DOWNTOWN
DISTRICT CONSTITUTING THE JURISDICTION OF THE DOWNTOWN
DEVELOPMENT AUTHORITY; AND TO PROVIDE FOR ALL OTHER MATTERS
NECESSARY AND RELATED THERETO

The Village of Stockbridge ordains:

SECTION 1. Title.

This Ordinance shall be known and may be cited as the "Downtown Development Authority Ordinance."

SECTION 2. Definitions.

The terms used in this Ordinance shall have the same meaning as given to them in Act 197 or as hereafter defined provided unless the context clearly indicates to the contrary. As used in this Ordinance:

- (a) "Authority" shall mean the Stockbridge Downtown Development Authority as created herein.
- (b) "Act 197" shall mean Act No. 197 of the Public Acts of Michigan of 1975 as now in effect and hereafter amended being MCLA 125.1651 et seq; MSA \$5.3010(1) et seq.
- (c) "Board" shall mean the governing body of the Authority.
- (d) "Council" shall mean the Council for the Village of Stockbridge.
- (e) "Downtown District" means the downtown district designated by this Ordinance as now existing or hereafter amended.

#### SECTION 3. Creation of Authority.

(a) There is hereby created pursuant to Act 197 a Downtown Development Authority for the Village of Stockbridge, Michigan. The Authority shall be a public body corporate and shall be known and exercise its powers as the "Stockbridge Downtown Development Authority."

(b) The Authority shall develop the plans necessary or appropriate which, in the opinion of the Village Council, aids in the economic growth of the district. Once the plans are approved by the Council, the Authority shall implement any plans for development in the district necessary to achieve the purpose determined by the Village through its adoption of such plans and other purposes as provided in Act 197.

SECTION 4. Description of Downtown District.

The Downtown District, in which the Authority shall exercise its power as provided by Act 197, shall consist of the following described territory in the Village of Stockbridge, Michigan, subject to such changes as may hereinafter be made pursuant to this Ordinance and Act 197:

All of the area contained within the duly established boundaries of the Village of Stockbridge.

- SECTION 5. Establishment of Governing Board.
  - (a) Membership qualifications, terms, vacancy, compensation and expenses, chairperson.

The Authority shall be supervised and controlled by a Board consisting of the President of the Village of Stockbridge and at least eight but no more than twelve members, none of whom may simultaneously be members of the Council, to be determined by resolution of the Council. The members of the Board shall be appointed by the President subject to approval of the Council. At least a majority of the members of the Board shall be persons having an interest in property located in the downtown district. At least one of the members shall be a resident of the downtown district. Of the members first appointed an equal number of members, as near as is practicable, shall be appointed for one year, two years, three years and four years. A member shall hold office until the member's successor is appointed. Thereafter, each member shall serve for a term of four years. An appointment to fill a vacancy shall be made by the President for the unexpired term only. Members of the Board shall serve without compensation but shall be reimbursed for all actual and necessary expenses. The chairperson of the Board shall be elected by the members of the Board.

(b) Oath.

Before assuming the duties of office, a member shall qualify by taking and subscribing to the Constitutional Oath of Office.

(c) Open Meetings Act, compliance; rules; special meetings.

The business which the Board may perform shall be conducted at a public meeting of the Board held in compliance with Act No. 267 of

the Public Acts of 1976, being sections 15.261 to 15.275 of the Michigan Complied Laws. Public notice of the time, date, and place of the meeting shall be given in the manner required by Act 267 of the Public Acts of 1976. The Board shall adopt rules consistent with Act No. 267 of the Public Acts of 1976 governing its procedure and the holding of regular meetings, subject to the approval of the Council. Special meetings may be held when called in the manner provided in the rules of the Board.

(d) Removal of Board member for cause; judicial review.

Pursuant to notice and after having been given an opportunity to be heard, a member of the Board may be removed for cause by the Council. Removal of a member is subject to review by the Circuit Court.

(e) Expenses and financial records, open to public.

All expense items of the Authority shall be publicized monthly and the financial records shall be open to the public.

(f) Freedom of Information Act, compliance.

In addition to the items and records prescribed in subsection (e), a writing prepared, owned, used, in the possession of, or retained by the Board in the performance of an official function shall be made available to the public in compliance with Act No. 442 of the Public Acts of 1976, bineg sections 15.231 to 15.246 of the Michigan Compiled Laws.

#### SECTION 6. Board Officers and Personnel.

(a) Director; oath and bond, chief executive officer; powers and duties; report; acting director.

The Board may employ and fix the compensation of a director, subject to the approval of the Council. The director shall serve at the pleasure of the Board. A member of the Board is not eligible to hold the position of director. Before entering upon the duties of his office, the director shall take and sub-scribe to the Constitutional oath, and furnish bond, by posting a bond in the penal sum of Five Thousand Dollars payable to the Authority for use and benefit of the Authority, approved by the Board and filed with the Village The premium on the bond shall be deemed an operating expense Clerk. of the Authority, payable from funds available to the Authority for expenses of operation. The director shall be the chief executive officer of the Authority. Subject to the approval of the Board, the director shall supervise, and be responsible for, the preparation of plans and the performance of the functions of the Authority in the manner authorized by this Ordinance and Act 197. The director shall attend the meetings of the Board, and shall render to the Board and to the Council a regular report covering the activities and financial condition of the Authority. If the director is

absent or disabled, the Board may designate a qualified person as acting director to perform the duties of the office. Before entering upon the duties of his office, the acting director shall take and subscribe to the oath, and furnish bond, as required of the director. The director shall furnish the Board with information or reports governing the operation of the Authority as the Board requires.

(b) Treasurer; duties; bond.

The Board may employ and fix the compensation of a treasurer, who shall keep the financial records of the Authority and who, together with the director, shall approve all vouchers for the expenditure of funds of the Authority. The treasurer shall perform such other duties as may be delegated to him by the Board and shall furnish bond in an amount as prescribed by the Board.

(c) Secretary; duties.

The Board may employ and fix the compensation of a secretary, who shall maintain custody of the official seal and of records, books, documents, or other papers not required to be maintained by the treasurer. The secretary shall attend meetings of the Board and keep a record of its proceedings, and shall perform such other duties delegated by the Board.

(d) Legal counsel; duties.

The Board may retain legal counsel to advise the Board in the proper performance of its duties. The legal counsel shall represent the Authority in actions brought by or against the Authority.

(e) Other personnel.

The Board may employ other personnel deemed necessary by the Board.

SECTION 7. Powers of the Board.

#### The Board may:

- (a) Prepare an analysis of economic changes taking place in the downtown district.
- (b) Study and analyze the impact of growth upon the downtown district.
- (c) Plan and propose the construction, the renovation, repair, remodeling, rehabilitation, restoration, preservation, or reconstruction of a public facility, an existing building, or a multiple family dwelling unit which may be necessary or appropriate to the execution of a plan which, in the opinion of the Board, aids in the economic growth of the downtown district.

- (d) Develop long-range plans, in cooperation with the agency which is chiefly responsible for planning in the Village, designed to halt the deterioration of property values in the downtown district and to promote the economic growth of the downtown district, and take such steps as may be necessary to persuade property owners to implement the plans to the fullest extent possible.
- (e) Implement any plan of development in the downtown district necessary to achieve the purposes of this Ordinance, in accordance with the powers of the Authority as granted by Act 197.
- (f) Make and enter into contracts necessary or incidental to the exercise of its powers and the performance of its duties.
- (g) Acquire by purchase or otherwise, on terms and conditions and in a manner the Authority deems proper or own, convey, or otherwise dispose of, or lease as lessor or lessee, land and other property, real or personal, or rights or interests therein, which the Authority determines is reasonably necessary to achieve the purposes of Act 197, and to grant or acquire licenses, easements, and options with respect thereto.
- (h) Improve land and construct, reconstruct, rehabilitate, restore and preserve, equip, improve, maintain, repair and operate any building, including multiple family dwellings, and any necessary or desirable appurtenances thereto, within the downtown district for the use, in whole or in part, of any public or private person or corporation, or a combination thereof.
- (i) Fix, charge and collect fees, rents and charges for the use of any building or property under its control or any part thereof, or facility therein, and pledge the fees, rents and charges for payment of revenue bonds issued by the Authority.
- (j) Lease any building or property under its control, or any part thereof.
- (k) Accept grants and donations of property, labor, or other things of value from a public or private source.
- (1) Acquire and construct public facilities.

#### SECTION 8. Funds.

#### (a) Sources.

The activities of the Authority shall be financed from one or more of the following sources:

(1) Donations to the Authority for the performance of its functions.

- (2) Monies borrowed and to be repaid as authorized by section 13 of Act 197.
- (3) Revenues from any property, building or facility owned, leased, licensed or operated by the Authority or under its control, subject to the limitations imposed upon the Authority by trusts or other agreements.
- (4) Proceeds of a tax increment financing plan, established under Sections 14 to 16 of Act 197.
- (5) Monies obtained from other sources approved by the governing body of the municipality.
- (b) Deposit and payment of monies.

Monies received by the Authority and not covered under subsection shall immediately be deposited to the credit of the Authority, subject to disbursement pursuant to this Ordinance. Except as provided in this Ordinance or in Act 197, the Village shall not obligate itself, nor shall it ever be obligated to pay any sums from public funds, other than monies received by the Village pursuant to this section, for or on account of the activities of the Authority.

## SECTION 9. Fiscal Year; Adoption of Budget; Financial Reports.

- (a) The fiscal year of the Authority shall begin on April 1st of each year and end on March 31st of the following year, or such other fiscal year as may hereafter be adopted by the Council.
- (b) The Board shall annually prepare a budget and submit it to the Council on the same date that the proposed budget for the Village is required to be submitted to the Council. The Board shall not finally adopt a budget for any fiscal year until the budget has been approved by the Council. The Board may, however, temporarily adopt a budget in connection with the operation of any improvements which have been financed by revenue bonds where required to do so by the Ordinance authorizing the revenue bonds.
- (c) The Authority shall submit financial reports to the Council as requested by the Council. The Authority shall be audited at the same time and by the same independent auditor auditing the Village accounts and copies of the audit report shall be filed with the Council.

### SECTION 10. Termination of Authority.

An Authority which has completed the purposes for which it was organized shall be dissolved by ordinance of the Council. The property and assets remaining after the termination shall belong to the Village of Stockbridge.

#### SECTION 11. Severability.

If any provision of this Ordinance shall be held invalid, its invalidity shall not affect any other provision of this Ordinance that can be given effect without the invalid provision, and for this purpose the provisions of this Ordinance are hereby declared to be severable.

SECTION 12. Effective Date.

This Ordinance shall take effect immediately upon publication and the filing of a copy of the same with the Secretary of State.
